<u>Director's updates</u>: Wuorenmaa provided information regarding project travel. More project information will follow in the presentation.

<u>Final FY2023 budget amendment</u>: Wuorenmaa explained the final revisions since the original budget. <u>FY2024 General Appropriations Act – budget adoption</u>: Wuorenmaa presented the FY2024 General Appropriations Act. Western U.P. Rail Commission (Chair Bonovetz): Chair Bonovetz explained a proposal created by Store and Bonovetz about the potential for the rail corridor to go from Wakefield to White Pine mine. Store and Bonovetz would like to see a Western UP rail commission with the rail line starting at the Wisconsin/Michigan border going to White Pine. Research is being done to find out what the process is to get a Michigan rail commission. Trail potential is also in consideration. Senator McBroom's office has been contacted about how to establish a rail commission. Gogebic county passed a resolution and Ontonagon County is reviewing at their next board meeting. Hyttinen will forward Gogebic's resolution to the Full Commission to review and revise to their information.

<u>Consideration of member contributions</u>: Wuorenmaa presented information and proposed county member contributions be increased by 25% split over the flat amount each county pays and the amount that's based on population and SEV. Hyttinen to send out to the Full Commission.

<u>Other business</u>: Questions regarding commission alternatives and the actual appointment process for alternatives and additional members. Each chief elected official would notify WUPPDR of those elected to the WUPPDR commission. Moved by Eilola, supported by Hautala to accept this process. <u>Motion carried</u>.
